2. Applicant **MUST** direct a full day, full year child care program serving a range of ages in the early childhood years;
3. Applicant **MUST** have at least three years director experience with the child care center named in the application;
4. Applicant **MUST** have a current membership in good standing with NACCP;
5. Applicant **MUST** be able to attend the award ceremony at the NACCP annual conference.

Part 5. Letters in Support of the Applicant's nomination.

You may submit up to three (3) letters supporting this individual's application written by staff members, parents, or anyone wishing to participate. Each letter should include the name of the applicant, the name of the writer and the writer's affiliation with the applicant.

Please be sure to submit the letters at the same time you submit this application. If you submit the application by email, the letters should come by email as well. You may also choose to submit the application and the letters by mail as hard copies.

Presentation Format and Deadline:

- * Applications that do not meet the required criteria will be disqualified.
- * A completed application form must be included with the letters of support.
- * At a later date, the winner will be asked to provide a professional photograph in a timely manner for the NACCP publication.
- * Applications must be **postmarked** no later than **March 1, 2007** (no faxes, please).
